## THE ONEHUNGA WHARF EXTEN-SION ACT, 1875.

IN THE THIRTY-EIGHTH YEAR OF THE REIGN OF HER MAJESTY QUEEN VICTORIA.

## 1875. SESSION XXX. No. 10.

WHEREAS by Crown Grant bearing date 1st February 1861 certain properties were granted in pursuance of "The Public Reserves Act 1854" to the Superintendent of the Province of Auckland upon trust for the improvement of the Harbour of Manukau and the construction and maintenance of such Docks Piers and other works therein as may be deemed advisable for facilitating the trade and commerce of the Port of Manukau

AND WHEREAS a certain Wharf known as the Government Wharf has been erected at Onehunga on portion of the said Endowments but such Wharf is insufficient to meet the requirements of the Port

AND WHEREAS by an Act of the Auckland Provincial Legislature entituled "The Manukau Harbour Endowments Debt Repeal Act 1874" all profits arising from the Harbour Endowments and Wharves are devoted to the extension of Wharf accommodation and the improvement of the Endowments

AND WHEREAS the Superintendent is by the Public Reserves Act debarred from raising money by way of mortgage (except for a period of 3 years) on the security of the trusts without the sanction of an Act of the Provincial Council and it is expedient that the Superintendent should be empowered to mortgage the said Wharf and the rents profits and issues arising therefrom for a longer period for the purpose of raising a sum not exceeding  $\pounds 6,000$  to be expended in increasing Wharf accommodation at Onehunga

BE IT THEREFORE ENACTED by the Superintendent of the Pro-

vince of Auckland with the advice and consent of the Provincial Council thereof as follows :----

1. The Short Title of this Act shall be "The Onehunga Wharf Extension Act 1875."

£6,000 authorized to be borrowed.

Short Title.

2. The Superintendent is hereby authorized to raise by way of mortgage on the security of the Government Wharf at Onehunga and the rents profits and issues arising therefrom a sum not exceeding  $\pounds$ 6,000 at a rate not exceeding 8 per centum per annum for the purpose of increasing Wharf accommodation at Onehunga and carrying out the objects of the Trust.

Mortgage not to ex-ceed 10 years.

3. The money hereby authorized to be raised by mortgage shall be for such term as the Superintendent shall think fit not exceeding 10 years.
