

**AN ACT to amend "The Treasury Bills Regulation Act 1868."** Title.  
[3rd September 1869.]

**W**HEREAS it is expedient that powers should be given to circulate and exchange Treasury Bills not only within the Colony of New Zealand but also within the Australasian Colonies and to provide for the payment of such Treasury Bills at some place within the Colony in which the same may have been put into circulation and exchanged. Preamble.

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows—

1. The Short Title of this Act shall be "The Treasury Bills Regulations Act Amendment Act 1869." Short Title.

2. "The Treasury Bills Regulation Act 1868" is hereinafter referred to as "the said Act" and this Act shall be construed and read with and as part of the said Act as amended hereby and the term "Australasian Colonies" where used in this Act shall include the Colonies of New South Wales South Australia Tasmania Victoria and Queensland. Interpretation.

3. Notwithstanding anything to the contrary in the said Act all Treasury Bills which shall hereafter be made out under the authority of any Act or Acts of the General Assembly whether as original Treasury Bills or in the place of Treasury Bills from time to time paid off may be circulated or exchanged either in New Zealand or in any of the Australasian Colonies by the Colonial Treasurer or by any person appointed by the Governor or the Colonial Treasurer may contract in writing with any person to circulate and exchange at his Treasury Bills authorized to be made may be circulated either in New Zealand or any of the Australasian Colonies.

own cost any such Treasury Bills not only in Wellington or elsewhere in the Colony of New Zealand but also at any place or places in the Australasian Colonies.

Interest on and principal of Treasury Bills circulated in Australasian Colonies to be paid at such place as shall be named in such Bills.

4. As to any such Treasury Bills circulated or exchanged at any place in the Australasian Colonies the notices required by the fifth section of the said Act shall be made and published in the *Government Gazette* of the Colony in which the same shall have been put into circulation or exchanged or in such other manner as the Governor shall from time to time direct and payment of such Bills and the interest thereon shall be made at such place in New Zealand or any of the Australasian Colonies as the Colonial Treasurer shall determine and as shall be named in such Bill.
